- The Doctors, Dental Surgeons and Staff Nurses already working in Wapda Medical Services on temporary basis are only eligible to apply for the above mentioned posts. They will submit their applications to NTS after verification from the concerned Medical Superintendents.
- No TA / DA will be allowed to candidates for test by NTS and interview by WAPDA.
- The candidates obtaining 50% or more marks will be called for interview.
- Original documents must be presented by the candidates at the time of interview.
- Candidates may contact NTS for any query / enquiry regarding written test, roll number slips, test centers, results etc.
- WAPDA reserves the right to withhold the recruitment process at any stage.
- Last date for submission of applications is 20.10.2016.**

HOW TO APPLY

- Application Forms shall be downloaded from National Testing Service (NTS) website i.e. www.nts.org.pk
- Candidates shall submit application forms duly filled in alongwith test fee of Rs. 450/- in favor of National Testing Service, copy of CNIC and two recent passport size photographs directly to **NTS through courier on the address mentioned on Application Form NTS HEADQUARTER, 1-E. STREET NO. 46, I-8/2, ISLAMABAD** within 15-days of publication of advertisement (**UAN: +92-51-844-444-1**)
- Test Fee shall be paid in any branch of UBL, MCB, or ABL on prescribed Bank Challan (attached with application form downloaded from NTS website i.e. www.nts.org.pk, Incomplete applications or applications carrying incorrect information shall be rejected.
- Roll No. Slips containing the information regarding test center, timings and test date shall be separately dispatched directly to candidates by NTS at least one week before the test.
- Candidates can also download their Roll No. Slips from NTS website.
- Application submitted by hand will not be entertained.
