2. Bidders will supply Surgical and disposable/drugs items on discounted rates.
3. Bidders should have a valid Surgical and disposable/drugs items sale license in accordance with laws of Government and health department.
4. Contract will be valid for 01-year, and extendable to one year with mutual consent and satisfactory performance.
5. Sealed bid should be submitted with original letter heads of the surgical and disposable items bearing the name, address and contact number, being properly signed and dated by the proprietor or his authorized representative.
6. Bidding shall be conducted through **Single stage Two Envelope** bidding procedure of PPRA Rules 2004.
