QUALIFICATION

The candidate must possess a graduate degree in electrical or electronic or mechanical engineering or an equivalent degree to these from a university or institution recognized by the Higher Education Commission.

EXPERIENCE

The candidate must possess at the time of his appointment professional experience of not less than **twenty years** with at least **five years** of experience at a senior technical or managerial level position.

AREAS OF RESPONSIBILITY / JOB DESCRIPTION

The Member (Power) shall perform the following functions, as defined in WAPDA Act, 1958, namely:-

- i. Planning, construction, operation and maintenance of power plants
- ii Planning, rehabilitation and refurbishment of old hydel power plants;
- iii. Management of consultants and contractors during various phases of electro mechanical works of hydro power project
- iv. Maintain coordination with national grid system, power control, dispatch, Pakistan Electric Power Company (PEPCO), National Transmission and Dispatch Company (NTDC), National Electric Power and Regulatory Authority (NEPRA), Central Power Purchasing Agency Guarantee (CPPAG) and other power sector related entities.
- v. Management of local and foreign procurement in line with the Pakistan Engineering Council's Guidelines, rules made under the Public Procurement Regulatory Authority Ordinance, 2002 (XXII of 2002) and other protocols
- vi. Administrative and financial management of all formations of Hydel Power Wing of the Authority.
- vii Coordinating efforts with other wings and formations of the Authority to achieve set goals under the powers defined in the Pakistan Water and Power Development Authority Act, 1958 (XXXI of 1958)
- viii. Management of audit procedures and dealing with audit reports; and
- ix. Coordination with the Division to which business of water resources stands allocated
- x. Any other assignment, assigned by the Chairman.

- If a civil servant or an officer of the Authority is appointed as a Member, he shall draw pay in BPS-21 including such allowances as may be admissible from time to time in MP-II Scale.
 - Provided that where a civil servant who has been appointed as a Member has not been promoted to BPS-21, he shall draw the pay of his substantive pay scale alongwith such allowances as may be admissible from time to time in MP-II Scale.
- ii. If an officer of the armed forces is appointed as a Member, he shall draw the pay and allowances that he was drawing immediately prior to such appointment.
- iii. If any other person is appointed as a Member, he shall draw the pay and allowances as may be admissible from time to time in MP-II Scale.
